

Privacy Statement Veba Meditemp B.V. CoC reg. no.: 16061239

Issued by Veba Meditemp B.V., with its registered office in Uden

Your privacy is very important to Veba Meditemp. We therefore comply with the privacy law. This means that your data is safe with us and that we will only process personal data in accordance with the law.

This privacy statement only concerns the processing of personal data by Veba Meditemp B.V. Veba Meditemp B.V. is not responsible or controller for the processing of personal data by third parties.

In brief:

When processing your personal data, we adhere to the requirements of privacy legislation. That means among other things that:

- We clearly state the purposes for which we use personal data. We do this by means of this privacy statement;
- We clearly state the legal basis of processing your personal data;
- We limit our collection of personal data to only the personal data required for legitimate purposes;
- We first ask you for explicit permission to process your personal data in cases where your permission is required;
- We take appropriate security measures to protect your personal data and also demand that of parties that process personal data on our behalf;
- We respect your right to view, correct or delete your personal data upon request.

In this privacy statement we explain what we at Veba Meditemp BV do with the information that you provide to us or that we collect.

This privacy statement was last amended on March 20, 2020.

Use of personal data

When using our website and services, we may receive the following information from and about you:

Newsletter

- When you subscribe to our newsletter, we process your name and e-mail address

Social Media

- When you click on a Youtube and/or LinkedIn button, we can process personal data. For example when you click on the 'interesting'-button or leave a comment.

Contact us

- When you contact us, for example to make an appointment or when you have a question, we process your name, gender, company name, telephonenumber, e-mail address and your message to us.

Job applications

- When you apply for a job we process your cv and motivational letter.

Our services

- In order to provide our services we process the following personal data: company name, your name, e-mail address,

telephone number, copy of identity document, Social Security number, Bank account number.

The law calls this "personal data" and states that we may only use it if there is a legal basis for it, as mentioned in the GDPR:

- Sending information via e-mail at your request (permission);
- Answering your questions or complaints (permission);
- Executing our agreement with you (performing an agreement);
- Compliance with obligations under the Wwft and Sanctions Regulations (legal obligation);
- Improving our website and services (legitimate interest);
- Review job applications (permission);
- Social media (permission);
- For statistical purposes (permission).

In legal terms, this means that we use your data at your request, when we have an agreement with you, when we have a legitimate interest or when we are required to do so by law.

Storage

We store your data for as long as necessary to achieve the purpose for which we process your personal data, for example for as long as necessary to provide our services to you. When we no longer need the data for that, they are permanently erased or made anonymous, unless we have a legal obligation to keep the data longer or we save the data for statistical purposes.

Providing data to other companies or institutions

We will only give your personal data to other companies or institutions if this is necessary for the functioning of our website and/or services (this includes storage by our hosting provider), if we are required to do so by law (for example when required by government authority) or if you have given us specific permission.

Your personal data will not be transferred outside of the European Economic Area.

Cookies

Our website uses functional and non-functional cookies related to, among others, measuring visitor numbers and remembering the language choice of the user of the website. Cookies are small files in which we can store information so that you do not always have to enter it. Functional cookies are necessary for the functioning of the website and make no or only minor infringement of the privacy of the visitor to the website. These cookies do not require permission from the visitor to the website. For more information about the use of cookies we refer to our cookie policy.

Security

Security of personal data is very important to us. We take security measures to prevent misuse of and unauthorized access to personal data. For example, we use secure network connections and secure accounts on a personal level. That means that the connection between you and us is secure. Data transferred between your and our systems will be held in confidence.

Changes to this privacy statement

When our websites and/or services change, we must of course also modify the privacy statement. Always pay attention to the date above and check regularly for new versions. We will do our best to announce changes separately.

Access to and changes to your data

If you have any questions or would like to know what personal data we hold about you, you can always contact us. Please see the contact details below.

You have the following rights:

- Explanation about what personal data we have and what we do with it;
- Access to the precise personal data that we hold about you;
- Having errors corrected;
- Removing outdated personal data;
- Moving your data;
- Withdrawal of permission;
- Object to a specific use.

Please note that you must always clearly state who you are, so that we are sure that we will not modify or delete data from the wrong person.

Submitting a complaint
